### I. GENERAL BOARD MEETING

1. Call public meeting to order

David Sweet called the meeting to order at 5:10 p.m. with the above listed board members being present and absent.

4. Discuss / act on monthly ES Corp. Treasurer's Report

Nichol made a motion to accept the monthly treasurer's report, as presented. Board Member Johannesen seconded the motion, which passed unanimously of those present (Ash was absent, and 1 vacancy existed on the ESC (one, City of Rockwall rep.).

5. Discuss / act on monthly Emergency Management program report, including update on COVID-19 related issues throughout the county

County Emergency Management Coordinator, Barbara Neville, updated the board on her department's monthly reports. She indicated that they are wrapping up COVID-19 vaccination clinics on June 11. The County will still be receiving vaccine doses from the State, but they will be transferring them to private partners within the county so that those partners may administer the doses. She encouraged anyone and everyone who has not been vaccinated but would like to be, to visit <a href="www.vaccines.gov">www.vaccines.gov</a> to find a COVID-19 vaccination administrator nearby. Neville went on to brief the board on various (non-COVID related) projects and activities that she and her staff members have been participating in over the course of the last month.

Sweet moved to accept Neville's monthly Emergency Management report. Board Member Nichol seconded the motion, which passed unanimously of those present (Ash was absent, and 1 vacancy existed on the ESC (one, City of Rockwall rep.).
